

Principals, it is that time of year again, the legislature is in session and we must make our voices heard. It is difficult to

rationalize complaining about something that one hasn't attempted to change or, at least, offer opposition opinions. Currently we are hearing a lot of noise about the school calendar issue. Make your views known to your legislative representatives and encourage others to do the same.

I recently saw a news story that is traveling around social media about a teacher who quit a job after two months due to student behavior. This particular teacher said that he just could not take it any longer. With approximately 14% of all teachers leaving the profession and colleges graduating fewer prepared teachers this needs to be addressed quickly. We already know that the shortage is currently impacting schools all over our state. So, what is the answer?

The answer involves, in my opinion, all levels of educators coming to the table, a task force if you will, that will investigate the root causes of the shortages and teacher retention. Then, to suggest strategies and processes that might be put into place to attract and retain good educators. As for classroom behavior, we need access to more mental health professionals in our schools and systems to better address the needs of our students.

While I do not believe that the answers will come easily, we must take a look at society as a whole and realize that change is necessary in order to assure that all people feel valued and see their worth as citizens. Mental health services are desperately needed in our schools and to be made available to our families who also need easier access to general health services.

Most importantly, I think it is not fair to blame everything on children and their behavior.

Federal Relations

The coronavirus and its effect on the nation is the major topic of discussion and concern. However, the regu-

lar functions of government still continue. For the fourth year, the President's budget proposal has major cuts for education. The proposed 2021 budget has a 7.8% cut in it for education. The proposal also consolidates 29 major K-12 programs - including Title I, Title II and Title IV into a single \$19.4 billion block grant. These funds would be sent to the states for them to decide its division, Congress has passed budgets that have been the strongest for education in the past several years. We will need to work with our Congressmen and Senators to keep this going.

The Secretary of Education and the President have not made much headway in their push for charter schools. They are still pushing for voucher programs. The Education Freedom Scholarships (EFS) proposal creates a \$5 billion annual federal tax credit for voluntary donations to state-based scholarship programs. They have had very limited success but are mounting another big push.

In March a group from AAESA is scheduled to go to D.C. to meet with our representatives. This may be canceled or postponed because of the virus. Our Congressmen respond very well to real life stories of how the federal government impacts students. If you have a story of how your school has been impacted by federal funding with those going.

The impact of vaping on our youth has become a major health concern. The Trump administration also announced that it will prohibit fruit, candy, mint and dessert flavors from small, cartridge-based e-cigarettes that are popular with high school students. But menthol and tobacco-flavored e-cigarettes will be allowed to remain on the market. In February, Congress passed the Reversing Youth Tobacco Epidemic Act. The Senate is now considering the bill.

the end of a great year! No doubt, you will be busy with the end of the third quarter of the year and the beginning of the fourth quarter. You will also be working hard to ensure that spring testing goes smoothly for everyone under your care. I have complete faith the in elementary leaders in our great state to ensure that our youngest learners finish with a flourish. AAESA and I stand ready to help in any way we can.

The 2020 legislative session began on Feb 5, 2020, and all AAESA members will need to be engaged in the legislative process. The number one factor in this process is engaging legislators in the home district, and who better to discuss the needs of elementary schools than elementary administrators. Please stay abreast of the issues on a regular basis, and don't hesitate to let us know when you have questions. You can check our website for updates and upcoming events including our CLAS Hill Days during the session. If you have a question about one of the events, please contact Rickey Darby or me, and we can help with an answer.

One of our major endeavors during this legislative session is the Tier III Bill that would increase the benefits of all educational employees hired after January 1, 2013. Currently, these employees are in Tier II and must work 40 years to be able to retire and draw benefits. Additionally, Tier II employees have a 1.65 multiplier and cannot use accrued sick leave towards retirement. We are trying to change this and allow educators to retire and draw in 30 years. We are also trying to allow accrued sick leave to be used for retirement. In addition, we are hoping to increase the multiplier up from 1.65. Please let us know if we can assist you in any way with this issue.

Also, we are facing a move to change the calendar. Our position is very clear that school calendars are a local issue and should be left to the local systems and communities for deciding the school calendar. Finally, we know that an educational package from Senator Marsh will be forthcoming in late March or early April. We do not know what will be in the package; however, we do believe it will be comprehensive and cover educational issues from pre-k through higher education. Stay tuned on this one.

Additionally, mid-March will find the AAESA leaders in Washington during the annual National Leaders Conference. During this event, we will engage the congressional and senate delegations from Alabama in an effort to impress upon them the importance of sound educational policy. Dr. David Fancher has done an excellent job working for you all to keep us abreast of national legislation impacting education. Updates will be forthcoming in future Friday and Legislative Updates.

By the time you get this issue, we will have announced the 2020 NAESP Alabama National Distinguished Principal. We have some great candidates for this very important honor, and I know that whoever is named the 2020 NDP will represent our state wonderfully well. Join me one more time in thanking our 2019 NAESP Alabama National Distinguished Principal, Dr. Michael Wilson, for being such a wonderful ambassador for Alabama and elementary leaders.

As a reminder, please craft your narrative or someone else will craft if for you. We have so many great things going on in education in our great state, and if you don't let people know about it, others will make incorrect assumptions about your school. After all, people outside your stakeholder group may only know about you from a letter grade.

PROPOSED BYLAWS CHANGE

At the Spring Planning meeting of the AAESA Executive Board

on February 28, 2020, a proposed bylaws change was presented. According to the bylaws, a proposed change must be presented in writing to the Board; if approved, the change should be submitted to the members prior to the next business meeting at which it would be voted on by the members present. To fulfill the next step in this requirement, the following is presented:

ARTICLE VIII NOMINATIONS AND ELECTIONS

Section D

The President shall appoint an Election Committee consisting of three or more active members. Elections shall be by electronic ballot

The responsibility of the Elections Committee is to prepare, collect, and tabulate ballots in all elections of the Association. A plurality shall determine an election. In the event of a tie vote, a runoff election shall be held immediately. (Formerly #3)

The Assistant Executive Director shall confirm the election results to the President who will announce the results to the Board.

Rationale: Since elections are now conducted by electronic ballot from the CLAS/AAESA office, this section needs complete revision.

Champions for Education: Ruby Payne Edition

They have lined up topnotch keynote speakers—Ruby Payne and Baruti Kafele.

Over the next few months, NAESP is giving us the chance to get to know our speakers a little bit better. Find out what makes them passionate about education and where they see the future of education heading. Plus, they've shared with us their answers to some rapid-fire questions about what they wanted to be when they grew up, their go-to books, and more.

This edition features Ruby Payne, founder of aha! Process and an author, speaker, publisher, and career educator. Here are her views on addressing emotional poverty, discipline strategies, and which unconventional topic schools should be teaching.

What is emotional poverty? Emotional poverty is when the brain is unintegrated and unregulated, when the inner self is weak, the bonding and attachment is insecure, and the external environment tells you that you are "less than" and "separate from."

Why aren't current discipline strategies effective when addressing emotional issues? Many of our current discipline strategies are based upon the idea that the student is basically emotionally healthy and just needs readjustment. However, the emotional responses and behaviors that are occurring in schools now are based upon an emotional injury, which requires a different approach.

What's the biggest issue facing school leaders today? The incredible demands that are placed upon teachers and students by federal and state policy, some of which are actually psychologically abusive. Kindergarten students should be learning through activity and play. The constant testing and measuring takes away from time to learn. The second issue that is facing many school leaders is the shortage of teachers, particularly in rural areas. The third is the emotional issues that some students and parents are bringing into the campus. The fourth issue is the amount of time that must be spent on compliance, regulatory, and legal issues.

Which educator had the most impact on you during your school years, and why did he or she leave a lasting impression? I was so fortunate to have several. I loved my second grade teacher. Her lipstick and nail polish always matched! When I

was a consultant for a regional service center in Texas, I worked for an executive director who was phenomenal. I learned so much from him. He had the ability to identify talent in others and confront issues in a non-offensive way yet speak the truth. He genuinely liked people. He was gifted with political negotiation.

When you were a child, what did you want to be when you grew up? A teacher. Always a teacher. I would line up my dolls and play with them.

What was your favorite book as a child? As an adult? I loved to read. I did not have a favorite book. I loved mysteries and good literature and still do. I still read about 200-300 books a year. The recent book *Educated* really struck a chord with me. Probably my favorite book right now is 12 Rules for Life by Jordan Peterson.

What unconventional topic do you wish students could learn as a subject in school, and why? I wish we would teach students about food—cooking, baking, etc. It is such a fabulous way to learn math, but more important, it is a lifelong skill and understanding. It is a bonding activity. In the mid-1970s, three courses were taken out of high schools that have impacted our country significantly; we took out home and family living, personal finance, and food and nutrition. Those courses were replaced with STEM courses. The understanding was that the parents would teach those things to their children. Now, 45 years later, we are seeing the impact in America of not having those courses.

Recognized internationally for her work, Payne has helped students and adults of all economic backgrounds achieve academic, professional, and personal success.

Payne will present an eye-opening keynote on schools trying to address emotional issues with discipline strategies and why it might not be working. Social and emotional learning programs are critical for addressing emotional challenges, but we must also rethink our discipline procedures and policies. Her keynote address will be based on her new book *Emotional Poverty in All Demographics*, exploring the concepts and providing understanding, tools, and strategies that are more effective that those currently in use in most classrooms.


